An agile data transformation and circulation, the key to business users' autonomy and reactivity

Agence de Services et de Paiement (ASP) is a French public establishment in charge of the implementing European and national public policies, it manages over 200 financial aid schemes for a wide variety of fields. The ASP develops its activity on behalf of several ministries, local authorities, and public establishments



The initial requirement was to construct a solution which addresses a strong demand from the French government to strengthen the fight against frauds, especially in relation to the newly added partial activity financial aid, put in place by the government due to the Covid19 pandemic.

For the fight against frauds, the ASP required a solution to:

- cross multiple heterogeneous data sources.
- implement complex data extraction criteria based on business rules.
- compile analytical reports.
- load / update analyzed data.

The Solution was moreover to enable users to:

- build their own reports.
- carry out their own analyzes using data from the ASP and including their own data.
- provide more freedom, autonomy and flexibility to users to leverage their data.
- meet some specific data mapping requirements.

The ASP aim was to also address the question of how to administer and control the data flow within the organization and with external

entities, as large volumes of data must be extracted from a variety of heterogeneous external sources. The Suadeo solution addressed 4 primary requirements for business users:

- Control plan: to access scored files based on fraud risk criteria, defined by the authorizing officer, the ASP accountant, and the Ministry of Labor.
- Filing a complaint: constructing the elements for filing on suspected cases, reporting on the data concerned, qualifying the various associated amounts and being able to aggregate the data of all the complaints filed.
- Requisitioning: provide data at the press of a button for the judicial investigation services.
- Blocking/unblocking payments: visibility on suspected cases and report their payments blocking/unblocking.

To perform this, the ASP uses the main functions on the Suadeo platform, which guarantees a better data circulation in open formats that can be used by third parties.

- an internal catalog listing the datasets selected by external partners.
- a file explorer of all databases or data structures.
- data transfer management tool.
- a remarkably strong on-board security system.
- a low-code solution.

Suadeo self-data services platform was used to build a data repository to aggregate data from crossing multiple heterogeneous sources with complex extraction criteria.

Data are referenced through a semantic layer via Suadeo Data Catalog, and fraud detection rules exposed through Suadeo User Data.

Business users can build their Dashboards which are subject to ongoing changes according to the evolution of anti-fraud procedures and requirements, they generate reports in total autonomy, increasing their reactivity.

Some numbers and facts:

- 400 GB of data treated
- 2,600,000,000 lines
- 2,000 tables
- 60 users
- 11 Data sources.
- The technical architecture is made up of two servers.
- Business data are imported into a single database.
- The architecture is scalable.
- The Suadeo platform allows compiling in a single database, creating dashboards and accessing feedback through a secure web portal.
- Initial implementation time, 2 months.
